For instance, for next year's convention plan to have a bigger space area for our Pavilion and come forward as panelists to present and discuss our contribution as a country and value proposition, something PRIDCO is currently working on. Legislature and municipal governments can also make a difference by approving legislation to increase necessary funds for this sort of event. We also need to be fully trained and gather more skills and knowledge on innova-

tion that is leading the world economy. By doing so, lies the opportunity to attract the best physicians and scientists and necessary resources to market it and create strategic alliances with recognized centers of research, development, and clinical studies. Continued commitment from private and public sectors is crucial in marketing and leading the Island towards the goal of competing in the global market.

Having the right focus on the manufacturing and scientific industrial processes, guarantee us a brighter future in the biotechnology market. Puerto Rico can become one of the leaders of research and development and clinical trials. We are in the right direction but we need to invest more economic resources, and that can only be accomplished if all players (academy, government, and private sector) agreed that is our main focus.
